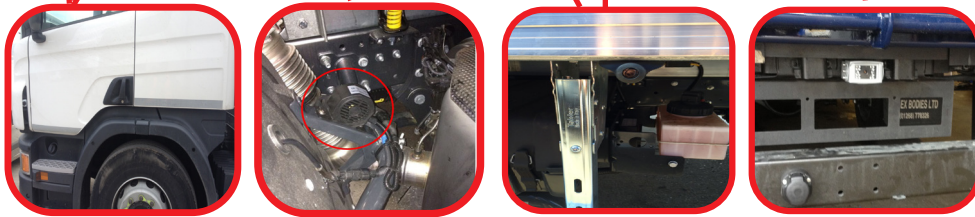
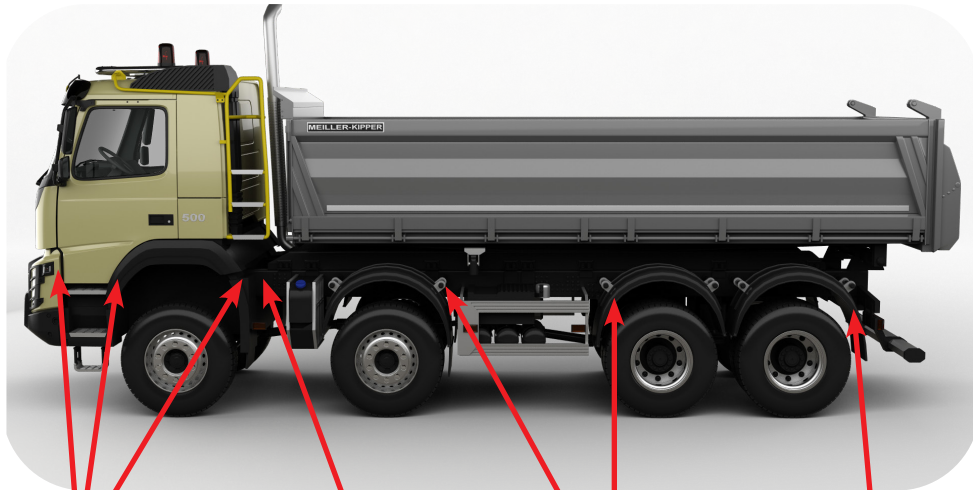


LDVS, FORS Silver and CLOCS Compliant Sytems



The Vision LDVS and CLOCS systems are specifically designed for vehicle operators that wish to meet the requirements of the LDVS, FORS and CLOCS schemes.

These systems uniquely integrate the nearside close proximity detection system with the monitor. So, if a cyclist or pedestrian is within detection range, an audible warning is played through the monitor whilst, simultaneously, displaying a warning message on the screen.



The LDVS systems include: Monitor, Nearside Side Camera, Nearside Proximity Detection System, Left Turn Alarm and Speed Turn On-Off Control Module. The FORS and CLOCS compliant systems adding a Reversing Camera to this system specification.

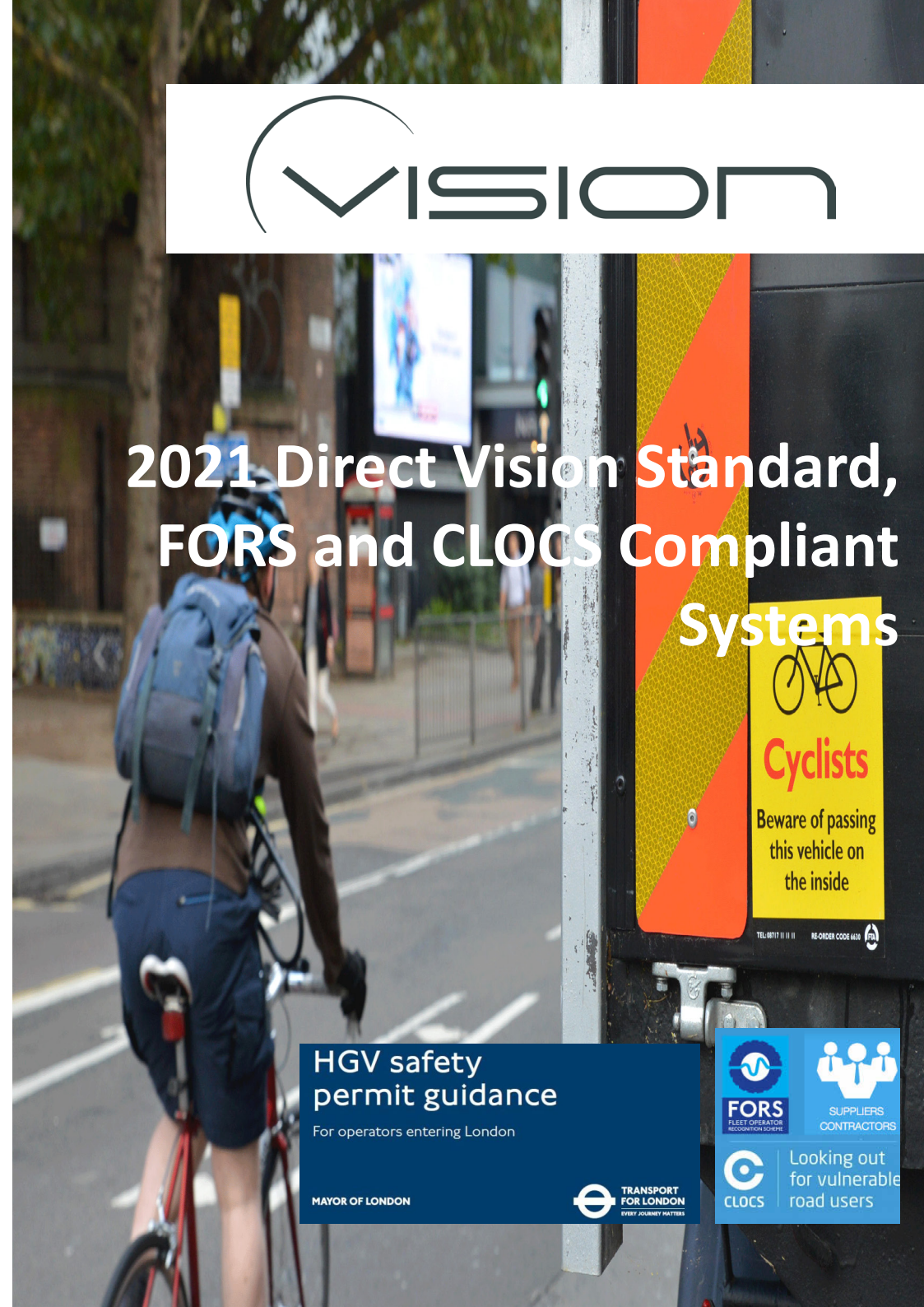

Our DVR-2040 solid state DVR Recorder features a comprehensive choice of Live View, Tracking and Remote Access upgrade options.

The FORS GOLD System package highlighted here incorporates this DVR with Front, Side & Rear Cameras - providing 360 vision around the vehicle - and our LDVS, FORS & CLOCS compliant integrated speed activated blind spot close proximity warning System with audible left turn manoeuvring alarm.



The LDVS, FORS and CLOCS Schemes

The focus of the LDVS and CLOCS schemes is to reduce accidents involving commercial vehicles and vulnerable road users & pedestrians. Reducing accidents is also a major focus of the FORS scheme but this scheme also covers many other aspects of vehicle operations.

After the 1st March, 2021 all vehicles over 12 tonnes entering Greater London will be required to meet the LDVS (London Direct Vision Standard) and registered with the "HGV Safety Permit Scheme".

The CLOCS scheme is specifically aimed at Construction Logistics Operators, and although it - and the FORS - schemes are voluntary, an increasingly large number of companies require that operators carrying their goods, or delivering to their sites, must be accredited by these schemes.

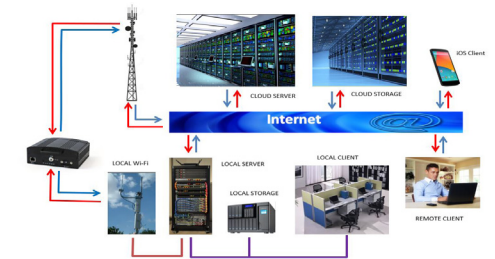
